Please read this form carefully and be aware that in participating in the above identified activities, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with said activities. AMA continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participant's safety.
